WOOD COUNTY SOLID WASTE MANAGEMENT DISTRICT **POLICY COMMITTEE MEETING**

April 21, 2025

The Wood County Solid Waste Management District Policy Committee met on the 21st day of April 2025. Commissioner Doris Herringshaw called the meeting to order at 8:36 a.m. Additional members present: Mayor Mike Aspacher, Judy Hagen and Joe Fawcett. Additional persons in attendance are listed on the attached roster. The Agenda was as follows:

- I. *Approval of November 18, 2024 Meeting Minutes:* The Committee reviewed the minutes from the last meeting and no additions or corrections were identified. Mayor Aspacher moved to approve the meeting minutes and Joe Fawcett seconded the motion. The members present voted aye, motion was approved.
- II. *Solid Waste Management District Update:*

Residential 24/7 Permanent Recycling Program: Assistant County Administrator Dan Scherger reviewed the monthly drop-off recycling program collection data. The County collected a total of 654.25 tons for 2024. The County collected a total of 155.36 tons thru March of 2025 so far. Mr. Scherger shared that Mr. Nemec will be tracking each site as to which sites are full and which sites are not full. With the tracking of each location this will allow for moving of a bin from a site that is not full to a site that is always full. This will help tonnage to increase and keep costs the same. (See attached Recycling tonnage)

Outreach & Program Planner Zach Nemec shared that there is a new 14th drop-off location in Lake Township. The new location is located at the Lake Township Fire Station 28 – 1911 Ayers Rd, Millbury. There are 5 bins at this location with no cardboard currently accepted at this location. Outreach for the new location included Lake Township Trustees Meeting, Lake Schools District Newsletter, Village of Millbury Council Meeting, SWMD Newsletter and mailers. This new location brings the total bin count to 66 for Wood County. The Village of Weston requested a new location for the drop-off containers in Weston. The containers are now located behind the library.

Recycling Outreach Update: Zach Nemec shared that he has posted an updated listing of available Christmas Tree Recycling options, the Solid Waste District has a New Solid Waste Vehicle, he has had miscellaneous presentations and tours, He participated in a BGSU Waste Audit in Union Oval, participated with the Electronics Recycling Drive with BGSU's Campus Sustainability, shared recycling information at the BGSU Eco-Fair, participated in the Adopt-A-Highway Cleanup with Veterans Service Office and ADR Progression. Zach Nemec shared Upcoming Events. He has a Recycling Presentation at St. Aloysius, Community Earth Day celebration at Montessori School of Bowling Green with games for learning, Recycling Presentation at Pemberville Otterbein SeniorLife, Annual Spring Township/Engineer Cleanup, Home Safe Home Presentation at Wood County District Public Library, Submitting 2024 Annual District Report, Safety Town at Kenwood, Electronics Recycling Drive with Elmwood Schools Community, Bowling Green Recycling Center and Landfill Tours, and the Wood County Fair. (See attached PowerPoint Presentation)

Financials: Dan Scherger presented the financial reports (See attached PowerPoint Presentation) comparing 2024 year-to-date revenue, expenses, and cash balance for the previous four years. He stated that the total revenue for 2024 is \$585,381.89, which is above the estimated revenue for 2024. Revenue is down from the year 2023 by \$17,191.00. The total expenditures through 2024 are \$517,288.52, which is down approximately \$10,000.00 versus 2023. There was a gap in 2024 for the Outreach position for a short time that reduced expenses. In 2025 we will have a full year of expenses for the Outreach

position and the addition of the Lake Township Drop-Off location that will add additional tips for those containers. The unencumbered balance stands at \$937,063.33 through 2024. (See Attachments)

Grant Updates: Zach Nemec shared that we were approved and awarded a 2025 Recycle Ohio Grant. This grant is for \$5,000.00 and match funds will be \$1,252.00 towards the contamination reduction grant that is part of the Solid Waste Plan. Two rounds of mailers will be sent out to Perrysburg Township and Village of Pemberville residents. The first mailer will be sent out in May 2025 and one in August 2025. Mr. Nemec will be contacting Rumpke to request another contamination audit in May. He will also be doing weekly site visits that will begin in May. He will hand out surveys, questionnaires and distribute flyers during those visits at both Perrysburg Township and Village of Pemberville.

III. *Landfill/Recycling Updates:* Zach Nemec shared an update on the Wood County Landfill Expansion. Approval was granted in December of 2024 from the Ohio EPA to begin placing trash in the new cell. The landfill staff is busy building Five Feet of required fluff layer in the new cell that should be completed by mid-May 2025. The remaining air space in the current cell is approximately 6 months. Mr. Nemec shared pictures of Cell 1A from January 15, 2025 and another picture taken March 27, 2025 to show the progress of the project. (See attached PowerPoint Presentation)

Dan Scherger shared a few other Landfill updates. Mr. Scherger will be meeting with the City of Bowling Green and AMP Public Power Partners on April 24, 2025 to discuss the plan to remove the 4 turbines located on the landfill property. There will be a meeting with Verdantas and OEPA to discuss the haul road to the new cell. In order to widen the road to 23 feet and install a guardrail on both sides, there needs to be modifications to the sediment pond to the east of the road. Also working with Verdantas to prepare a 10-15 year forecast of significant capital projects with timing and cost. Cell 1B is only 5-6 years away from construction. Discussions on relocation of the leachate tanks for the new cell, long term haul road recommendations, scale house recommendations to accommodate in and out of vehicles and traffic back up and shop availability to handle today's larger equipment. The Landfill's cash balance has been flat for the past three years and would like to see future success.

Judy Hagen shared that the Country Garden Club is working with the City to start organic recycling. Joe Fawcett added that the Country Garden Club will launch a 2 year pilot program in early May. There will be six bins at the Department of Public Service (Roachton Road) and six bins at the Department of Public Utilities (Boundary Road). The Country Garden Club is providing funding for the program.

Amanda Gamby shared that the recycling numbers cost rate are going up 12% in January this year. This is the first increase in five years. Drop-off continues to run itself. Recent storms have caused a mess, but public works has everything back in place. They are working with Phoenix Technologies with improvements to their site.

Ken Rieman shared his concerns with Phoenix Technologies as well. Mayor Aspacher assured Mr. Rieman that the City is working with Phoenix Technologies to help rectify the situation. Mr. Rieman shared that the Bowling Green Recycling Center tonnage is 1300 tons, which is a 40% increase. Prices for cardboard were high so the year was better. He mentioned that they will be needing additional support as it doesn't pay for itself anymore. A change they have made due to newspaper disappearing is one bale for magazines, catalogs, newspapers and office paper. This is a new classification called mixed residential.

TJ Hunt from Waste Management shared he was attending the meeting as they service Wood County.

VI. *Adjournment:* Joe Fawcett moved to adjourn the meeting and Judy Hagen seconded the motion. The members present voted aye, and the motion was approved. The meeting adjourned at 8:36 a.m.







LANDFILL UPDATES

Meeting scheduled for 4/24/25 with City of Bowling Green and AMP Public Power Partners to discuss the plan to remove the 4 turbines located on the landfill property.

Scheduling a meeting with Verdantas and OEPA to discuss the haul road to the new cell. In order to widen the road to 23 feet and install a guardrail on both sides we would need to make modifications to the sediment pond to the east of the road.

Working with Verdantas to prepare a 10-15 year forecast of significant capital projects with timing and cost. Cell 1B, leachate tanks, long term haul road recommendations, scale house optimization, shop ability to handle today's larger equipment.
